Declaration of RoHS Compliant Products

TDK Innoveta Inc. certifies that to its knowledge the delivered products are in conformance with the specifications provided in the datasheet for the product requested in the Purchase Order. If this product has been designated as RoHS compliant, we further certify that materials used to manufacture this product are compliant with the requirements of the European Union's Restriction on Use of Hazardous Substances ("RoHS") Directive, 2002/95/EC.

TDK Innoveta defines "RoHS compliant" to mean products that are compliant with the current RoHS requirements for all six substances, including the requirement that they not exceed the concentrations below, by weight in homogenous materials, unless exempt.

For the following six substances, concentration will be limited to:

- Lead 0.1% by weight (1000PPM)
- Mercury 0.1% by weight (1000PPM)
- Cadmium 0.01% by weight (100PPM)
- Hexavalent Chromium 0.1% by weight (1000PPM)
- PBB, PBDE 0.1% by weight (1000PPM)
